All proceeds from this event will go to 6 local charities including: Stanwood Camano Food Bank, Camano Center, Safe Harbor Clinic, CASA, ReMax Community Grant Chest and Stanwood Camano Resource Center.

PRIZES: There will be prizes for the 1st, 2nd and 3rd place. All other expenses and taxes not specified herein are the responsibility of the winners. The prize is awarded without warranty, express or implied, of any kind.

VOTING: Pumpkins will be assigned a random number and voting will be anonymous. Voting will take place by visitors of the festival via ballot on Saturday, October 6, 2018 from Noon-6:00pm. The awards ceremony will take place on Sunday, October 7, 2018 at Kristoferson Farm (time TBA). Winners will be contacted the night before October 7, 2018. You do not need to be present to claim your prize.

CONTEST RULES:

- If you are under 18 a parent or legal guardian must sign the liability waiver form on your behalf.
- The pumpkin can be carved or decorated or both. It has to be a real pumpkin.
- By submitting a pumpkin, you are giving us the right to re-publish its photo anywhere we choose. Should you win a prize, we have the right to publish your name.
- Inappropriate pumpkins will be disqualified. What is inappropriate will be determined by the Camano Pumpkin Project organizers and Kristoferson Farm.
- Pumpkins will not be returned to you. You may pick up your pumpkin between 3:00-3:30 on Sunday, October 7, 2018 if you wish to keep it.
- One entry per person.
